PLANNING DEPARTMENT

Forward Planning

The Draft County Development Plan consultation process commenced on the 21st April and runs until 2nd July 2021. Webinars were held for members of the PPN on the 20th May and for members of the public on the 26th May to promote the process.

Development Management and Planning Enforcement Activity

The table below summarises Development Management activity in May. A total of 48 valid planning applications were received, which is generally comparable to the preceding monthly figures since the beginning of 2021. Decisions issued on 29 applications, of which 26 were grants of planning permission.

Unfinished Housing Developments (UHD)

As Covid restrictions were lifted for construction activity, contractors began working in 8 no. estates, 5 in the Boyle MD area (Silveroe, The Warren, Cois Cuain, Canal Court and Maple Close) and 3 in the Roscommon MD area (Ard Ri, Shannonside and Waters Edge) primarily carrying out snagging works.

Roscommon County Council Area Staff are working in 2 no. estates in the Roscommon MD area (Ard Castle and New Road, Castlerea) primarily carrying out minor works.

Developers are working in 2 no estates, 1 in the Roscommon MD area (Cluain Ard, Roscommon) and 1 in the Boyle MD area (Cloonshanville Park, Frenchpark).

ECONOMIC AND DEVELOPMENT PROMOTION

Local Enterprise Office:

• Trading On Line Vouchers (TOVs):

24 applications have been received and approved to-date. Clients who received TOV approval in 2020 and whose deadline date is approaching are being followed up. Once received, claims are being processed in a timely fashion. Funding on offer reverted to 50% on the 1st January 2021. There are two Remote Trading Online Voucher Information Seminars available to book on the LEO Roscommon Website on June 30th June & August 4th.

- Evaluation & Approvals Meeting: The next meeting is provisionally schedule for June 24th.
- Client Stimulus Scheme: A condition of this Scheme is that clients who received refunds (38 in total) must have agreed beforehand to complete a project focused on driving key themes such as Competitiveness, both Operationally and Green, Capability across Leadership, Innovation, Strategic Finance and new Market Development which will support the mitigation of the effects of the Covid-19 and Brexit. The intention is that the funding and associated projects will provide businesses with a platform from which they can sustain and grow, thereby contributing to the recovery of the Irish economy. Tenders were received from 67 consultants, assessed and a Panel formed. On a gradual basis, clients are being contacted and matched with a suitable mentor. This initiative is to be completed with client reports received by the LEO under stipulated headings by 31st December 2021.
- **Microfinance:** 7 applications received and sent to MFI Y-T-D, with 5 successful; 1 pending; 1 declined. Work continues on the promotion of this source of finance.
- **Training:** Training to support the business community is ongoing and well received.
- EMPOWER Growth Programme: This Programme is run by the GMIT iHubs, supported by LEOs in Roscommon, Galway, Mayo, Leitrim, Sligo & Donegal. It is provided for females with established businesses looking to grow and scale their enterprise. Four applications were received from Roscommon based businesses, with one applicant successful in securing a place on the Programme: Sandra Ganey, owner of Jiving Juniors.
- **Remote Mentoring:** General one-to-one mentoring is ongoing. Brexit & Business Advice Clinics were held and continue to be offered on the LEO online booking system. All bookings are taken via the LEO website online booking system.
- Enquiries: Appropriate support provided on an ongoing basis.
- **Student Enterprise Programme:** The National Final took place virtually on Friday, 14th May. Rust Busters from Castlerea Community School weren't in luck on this occasion, having come to the fore at county level.
- National Enterprise Awards: The next Awards will take place in 2022.
- **Promotion:** All LEO supports were promoted on the LEO website and on various social media platforms.
- Sites at Ballyboughan: 4 Enquiries ongoing.
- Just Transition: 3 applications successful. Feasibility Study for the Boardwalk project successful, and two more Feasibility Studies for Cloontuskert Ballyleague Visitor Centre and Organic Farm and Cloontuskert Ballyleague Bog Heritage Train were successful with a total fund of €242k approx. Tender documents for 2 of the Feasibility Studies have been completed.
- EI LW has met with Meabh Conaghy, the new West Region Manager, who has also joined the LEO Projects Evaluation Committee.
- **IDA:** LW is keeping the line of communication open between IDA, CE & Senior Management of RCC in the hope of encouraging FDI to Roscommon.

COMMUNITY AND ECONOMIC AND DEVELOPMENT

Healthy Ireland

- No decision has been made by Pobal yet in respect to the request for additional funding to continue two Healthy Roscommon projects until the end of the year.
- Pobal have announced that a progress and financial return on Healthy Ireland Fund activities will be due on July 31st 2021.
- Pobal have also given a deadline of July 31st 2021 for the final return of all financial and progress reports relating to the Community Resilience Fund Keep Well Campaign.

Wellness Campaign:

- Conversations in Portrait: RCC are engaging with 8 participants in the Keep Well Conversations in Portrait 3 in Nursing Homes, 5 at home –
- Preparation ongoing by the Community Forum Sub-Group: Staying Connected/Managing Your Mood: 400 Age Friendly Care Packs distributed to the most isolated throughout the County. (Reps: RCC, HSE, AGS, RLP).

<u>CLÁR</u>

- Work in ongoing with Community Groups as they prepare tenders and quotations for commencement of work on their projects for CLÁR 2020 funded projects. Kiltrustan Sports Club have completed their project and have received payment for same.
- 10 applications in total were forwarded to the Department for Rural and Community Development for CLÁR 2021. The successful projects will be announced in July.

Community Enhancement Programme 2021

- Minister for Rural and Community Development, Heather Humphreys TD, and Minister of State with responsibility for Community Development and Charities, Joe O'Brien TD, have recently announced €4.5 million to support community groups impacted by COVID-19.
- The 2021 Community Enhancement Programme (CEP) will provide small grants designed to assist in the re-opening of facilities such as community centres, men's and women's sheds, parish halls and youth centres.
- The grants will range from a few hundred euro up to €10,000, however, exceptions will be made depending on the application.
- The funding is to help groups and clubs get back on their feet and may be used to carry out necessary renovations and repairs or to purchase equipment such as tables and chairs, tools and signage, laptops and printers, lawnmowers, canopies, training equipment and so on.
- The department allocation for Roscommon is €133,301.
- On the 19th of May and email circulated to the grants subcommittee of the LCDC seeking approval to advertise and publish the grant scheme as per the department guidelines and per application form. This offered the following options to the applicant:
 - Small scale grant of €1,000 or less Grant in excess of €1,000
- It was also agreed that this scheme would be online application made available from the 28th of May, 2021 with a closing date of midnight on the 20th of June, 2021.
- As per department guidelines the LCDC grants subcommittee agreed that 30% of the total funds (€39,990.30) be allocated to small scale grants of €1,000 or less with the balance (€93,310.70) to grants in excess of €1,000

Heritage

• Royal Sites of Ireland World Heritage Tentative List Application:

4 x technical sub group and 1 x steering group meetings took place to progress the Tentative List application under the guidance of Dr. Christopher Young. A press release was prepared and issued to local media to publicize the new <u>www.royalsites.ie</u> and public consultation survey. Social media posts were scheduled for the month and an email sent to the Heritage Office News mailing list to promote the website and public consultation survey. The survey was open for the month of May. A presentation was prepared for the Map Plenary meeting and letters of support for the tentative list application sought from the Chief Executive and Cathaoirleach. Letters of support have also been sought from other stakeholders. A meeting was held with Pio Byrnes from the Planning Department to discuss the planning policy context for Rathcroghan and collate the required information. Technician support has been requested to prepare some mapping required for the application. This project is being co-ordinated by Tipperary County Council.

• County Roscommon Heritage Forum:

The Heritage Forum met on 26.05.21 to consider a submission to the Draft Roscommon County Development Plan.

RCC Actions for Pollinators

A 'Biodiversity & Pollinators News Update' was emailed to Heritage Office News and community groups who had applied for Tidy Towns and Amenity Grants 2021. All subsequent queries and requests for publications and signage have been followed up.

Roscommon County Council has received its certification as a Partner to the All- Ireland Pollinator Plan. Site meetings took place with staff from Ballaghaderreen Area to discuss and trial actions for pollinators at Rathcroghan carpark & the Douglas Hyde Interpretation Centre.

• Historic Structures Fund 2021

Letters of offer were sent to 3 x successful applicants. Letters were sent to unsuccessful applicants. Follow up phone contact was made with all applicants to discuss their options.

• Irish-language shopfront stream of the Historic Structures Fund 2021

The Department of Housing, Local Government & Heritage announced the re-opening this funding stream on 14.05.21. The scheme was publicised on the council website and social media with a

closing date of 02.06.21. One query has been received to date, however the project was not eligible for the scheme.

• National Biodiversity Action Plan (NBAP) Grant 2020-2021

Funding was secured for 2 x projects:

Invasive Alien Species – Japanese Knotweed €18,826

Biodiversity Awareness - €25,600

These projects must be delivered by Q4.

Projects include supporting the **Irish Hedgehog Survey.** A workshop for Roscommon is scheduled for 02.06.21. A press release was circulated to local media, social media posts were scheduled and an email sent to Heritage Office News about the project & workshop.

Roscommon Arts Centre

On Tuesday 10th May, Roscommon Arts Centre was one of the first venues in Ireland to open its doors to the public for the first time in 2021. **Barbara Kenevivicz's exhibition** *'Tools for Well Being'* is the first in a series of newly commissioned work by the centre this year, made possible with the support of the Arts Council. Curated by Visual Art Curator in Residence, Naomi Draper, the exhibition includes the site specific development of the artists '*Scapes*' formations.

An accompanying video of the artist installing and speaking about the work was also produced, together with a Critical Text *"by way of cautious touches"* in response to the show by Visual Art Writer in Residence Sue Rainsford. Both are available to view online at: <u>roscommonartscentre.ie</u>

Bealtaine Festival Events: In May Roscommon Arts Centre delivered two Bealtaine projects, aimed at engaging with older members of the community with the support of Roscommon County Council's "Age Friendly Programme". "**My Dear Friend**" was a letter writing project between 5 older members of the public and 14 residents in nursing homes in Sacred Heart (Roscommon town) and Aras Mhathair Phoil (Castlerea).

Our second Bealtaine Project provided an opportunity for older members of the public to re-connect with song through a weekly virtual **"Songbirds"** series. Led by Cathy Jordan, 22 participants took part every week in workshops throughout the month.

Creative Engagement: Roscommon Arts Centre's Creative Learning Programme for 2021 is titled "Kaleidoscope". The programme aims to connect with people of all ages through a series of artistic engagements and cultural activity that helps develop a person's understanding, knowledge and skills. "Kaleidoscope" is being delivered by professional artists and practitioners and this month the first of two planned Kaleidoscope school programmes commenced virtually in schools throughout the county.

A total of 26 workshops will be delivered by professional artists and practitioners between now and the end of the school term in June. The programme is as follows:

- Animal Grooves: dance engagements for Junior First Class students
- Stargazing & Storytelling: astronomy and storytelling workshops
- Is Peace Possible? Zine Workshop for 3rd 6th Class students: A zine is a self-made, DIY, publication that brings together collage image, text and personal writing on a theme or question. Zines have historically been a popular way of communicating ideas and experiences of marginalised people by not having to go through mainstream publishers.
- \circ Meet the Writer: Primary Schools in Roscommon 3rd 6th Class
- **Ag Dull Ar Strae- Getting Lost:** a workshop which celebrates the different languages Irish, English, Polish and the other languages in the class, using drama, images and conversation

Fregoli Theatre Company Residency: This month 8 members of Fregoli theatre company continued with a series of professional development workshops as part of Phase 1 of their residency. Working with leading practitioners Debbie Wright, Raymond Keane and Annie Ryan, the company focused on movement, character development and performing in outdoor spaces.

Playing on the Radio: Work continues with actor Enda Oates on a new Creative Ireland project and members of Roscommon Drama Group. 12 members of the drama group will take part in two radio plays, directed by Enda, produced by Roscommon Arts Centre and rehearsed over the summer months. Plays will be aired in autumn 2021, with plans also being explored to perform the work as rehearsed readings on stage in September/October.

Audience Development Plan: work on the new audience development plan is continuing this month in-house.

Strategic Plan: This month, consultant Rowena Neville has also commenced work with the Centre Director on a new 5 year strategic plan for Roscommon Arts Centre, funding for which was secured via The Arts Council's capacity Building Award scheme in 2020. Engagements with key stakeholder will take place over the summer months and it is hoped that the plan will be produced in early September.
