We, the undersigned being affected landowners/owners/beneficiaries, who will benefit from or will be affected by the scheme, agree to be bound in all respects by each and every one of the terms and conditions of the Scheme, and, if the grant is made available, we agree to have the said work carried out by Roscommon County Council as Agent for each of us.

We hereby appoint the Applicant's Representative named below and delegate full power to him/her to act for us in all correspondence and other business arising from this application and we agree to be bound by such correspondence and by all acts of the said Applicant's Representative

We agree that Roscommon County Council in their discretion will decide on the specification and cost of the work to be done and on the best manner of carrying it out and shall not have any claim against the Council for any failure to complete the full amount of the work which was envisaged.

We agree that the Council undertakes only to expend the estimated sum to the best advantage and in the event of the sum being insufficient to complete the specified work, the Council will not have any liability to expend any further sum.

We hereby agree that the said Roscommon County Council, its staff and all other persons directed by them to enter upon our lands or holdings with or without vehicles to make, construct, lay down and/or repair and improve the road and erect fences and cut drains and take necessary materials and such land in addition to the width of the road as may be required for the construction of such road, fence and drains and to do all things necessary for the completion of the road.

We agree that we will arrange among ourselves for the provision of any land required, without cost to Roscommon County Council, for the construction or widening or a road for drainage works associated with the scheme.

We agree that Roscommon County Council will act as agents on our behalf to carry out the works and not in their capacity as a road authority and accordingly any road improved, shall, when completed, not be a public road.

We agree that when the work has been carried out, we bind ourselves to maintain the road in good order and repair at our own charge and expense and we agree that Roscommon County Council will not have any liability for the subsequent maintenance of the said road.

We agree that failing the fulfilment of any of the foregoing clauses on our behalf the work will not proceed or if already started will be closed down and any unspent portion of our contribution will be returned to us through our organiser/representative.
