Additional report of the University Committee.

Keeping in mind as a basic consideration the fact that Scholarships are provided for out of the rates with the object of helping the intellectual and brilliant children of the poor to obtain Intermediate and University education we submit to the County Council the following views : -

1. We consider there should be no discrimination between the children of ratepayers in the County whether those ratepayers be farmers or whether they be in receipt of salaries from other positions.
2. We consider that insufficient means and insufficient means alone (always providing the students be worthy individuals) should be the basis on which scholarships should be awarded.
3. But we consider that in fixing the standard of means above which scholarships may not be granted the present depressed condition of the ratepayers should be taken into account. Everyone knows that farmers and indeed many shopkeepers too find it almost impossible to meet their many and pressing obligations, and it would be farical and unjust to ask a poor man struggling, on ^{say} ten or twenty

acres of land, or with a languishing trade to contribute his quota to the upkeep of a boy or girl in College. whose parents are in receipt of four or five hundred pounds per annum or its equivalent. Unless there are exceptional circumstances such as large families or illness which cause reduction of this amount.

4. We therefore recommend that the County Council fix the standard of means at as low a figure as possible and that until times improve as few scholarships as possible be awarded and that these recommendations be inserted in the University Scheme 1924

I find that the making up of the Council's accounts each half-year of late has been exceedingly heavy because of the numerous loan accounts transferred from the abolished Rural District Councils' accounts for Housing loans, Trunk Road Grant payments and road-loans, statistics of finances called for by the Department of Local Government and Public Health, and extra work in relation to pensions, ex-workhouses, etc all these are in addition to the already very heavy financial work of a County Council. I may state that the payments necessitate the issue of 18,000 cheques yearly.

During the month allowed for making up a half-years accounts the applications for payments have to be examined for the Finance Committee's meeting, and they have become very numerous and troublesome.

In consequence of all these circumstances I need some help while the accounts are being made up, and of course that help will need to be expert.

any plots off those premises would be used
to redeem as far as possible the advance
made from the Land Commission towards
the purchase of these premises
