Planning Section Management Report - July 2018

Forward Planning

Vacant Site Levy work arising from the Urban Regeneration and Housing Act 2015

Further to the issuing of formal notification to property owners in June, relating to 30 sites, advising of the entry of the lands on the Vacant Sites Register, the next phase of activity commenced in July, with the commencement of valuations by the appointed Valuer. Following the conclusion of this work, notification of the valuations will issue to owners.

Of the 30 sites entered on the Vacant Sites Register, the Planning Authority has only been advised of one site to date which is the subject of an appeal to An Bord Pleanala.

Vacant Homes Office

Following receipt of Circular VHU 01/2018 in June from the DHPLG, a Vacant Homes Officer has been formally designated, to assume responsibility for vacant homes activity and progress initiatives to address identified vacancy in the key settlements of the county. The Vacant Homes Office has been incorporated into the Forward Planning section.

Development Management (including enforcement activity)

The table below summarises Development Management activity for July. A total of 54 valid applications were received, which was a slight increase on the number received in June. 36 decisions were issued on planning applications in July, of which 2 were refusals (5.5% refusal rate).

Unfinished Housing Developments

The Unfinished Housing Development team continued their work in July 2018, including undertaking site inspections and continued engagement with stakeholders.

Largely due to the summer holiday period, development activity on site was not as prevalent as in past months, but nonetheless showed continuing progress. Developers have been active in progressing agreed site resolution works in 4 developments, including two in Ballaghadereen, and one in Rooskey and Strokestown. In addition, a contractor appointed under Roscommon County Council's Framework commenced work on a development in Monksland.

The direct labour workers engaged by Roscommon County Council also continued with their programme, in developments in Ballinagare and Frenchpark.

Community and Enterprise Function

Diaspora:

• Joint feedback from the four counties been dealt with by Consultants. Further information on groups working with diaspora to be sent to consultants and revised draft to be issued.

RAPID 2017

- 9 projects approved for 2017.
- 8 projects completed with all relevant documentation received.
- 3 inspections carried out up to 31/07/2018.

<u>Clár</u>

- Successful applications under Measure 2 were announced in early July.
- Letters of Offer were issued to successful applicants.

Town and Village

- Work is ongoing in relation to increasing spend under 2017 T&V projects.
- Notification of 2018 projects will be in September 2018.

Outdoor Recreation

- At total of four applications were submitted under Measure 2 and 1 under Measure 3 for the closing date of July 25th.
- Notification of successful projects will be given by the DCRCD in September 2018.

Healthy Ireland

- Non-Financial report on 16 2017 projects was prepared and submitted for July 27th.
- Winners of No Smoking Campaign were presented with their prizes.

Pride of Place

- Judging for the 2018 Pride of Place Competition took place on Tuesday July 24th and Wednesday July 25th 2018.
- The visits consisted of a formal presentation by representatives of the local community
 highlighting their achievements and the reason why they deserve a Pride of Place award. This was
 followed by a walk to various initiatives in each of the three areas.
- Winners will be announced in November.

Tidy Towns and Amenity Grants

The 83 groups awarded funding under this scheme are carrying out their small scale capital
amenity and local enhancement projects currently and payments are being issued as works are
completed.

LCDC Related Activity

Roscommon LCDC met on July 31st.

CEP:

The new Community Enhancement programme (CEP) 2018 had national closing date of July 30th.

LCDC approved applications on July 31st giving maximum time for successful applicants to get their projects completed.

SICAP:

The mid-year reports were reviewed by the SICAP Sub-Committee in June along with the Pobal parallel review. All queries raised were responded to by the LDC and the sub-committee chairperson presented the committee recommendation to the LCDC on July 31st and the Mid Year review was approved by the LCDC.

LEADER:

- At 31/07/2018, 32 Projects approved to the value of €2,086,858.10.
- 3 claims paid to date totalling €38,252.68

• 26 Expressions of Interest received.

Age Friendly

- Attendance at the National Age Friendly Programme Managers meeting in the Mansion House on June 7th. Main discussion items were the draft Age Friendly Ireland Annual Report and a presentation from An Garda Siochana -National Strategy for Older People.
- Update report on Age Friendly programme given to JPC committee
- Programme status update given to National coordinators in Meath County Council
- Introductory meeting held with working group members including GRETB, OPC, Brothers of Charity and LEADER company representatives.
- Date proposed for 1st working group meeting end of Sept to allow OPC hold meeting on 27^{th Sept} and update AFWG.
- Intension to host Age Friendly Alliance meeting 1st week of November
- Projects progressing include WHO affiliation and official launch of Boyle as Age Friendly Town
- Age Friendly training for Town Teams and community group representatives scheduled for October in RRC HQ as part of Social Inclusion week

Social Inclusion

- Plans underway to develop Healthy estate in Boyle
- Call seeking projects for Social Inclusion week to be published in August.

Town Teams Community

- Tender request for Monksland Community Centre feasibility study consultancy works advertised via etenders
- Community Sports day scheduled for August in Monksland
- Roscommon Town Team Wellness weekend event scheduled for September

Arts Programme

- The Douglas Hyde Conference: The conference programme is now finalised for September 27th –
 29th. Thirteen speakers are confirmed for this year's event and the programme will be available
 from mid-August, when conference booking will also open. This year, the conference booking is
 being managed via Deirdre O'Gara at the Douglas Hyde Centre.
- Culture Night: nine events are now confirmed for this year's Culture Night on September 21st. The brochure for the evening is now being complied for distribution.
- Artists Bursaries: 21 artist bursaries have been awarded and to date 14 of those have drawn down their bursaries this month.
- Chapbook: 4 submissions from 13 artists have been received for this new programme initiative.
 Independent Selector, writer Noel King is now in the process of reading all submissions and it is anticipated that the winner will be announced in August.

King House Boyle

- A total of 4892 people visited King House in July of this year which brings the number of visitors for 2018 to 9127.
- The house was used as the location for the Boyle School Debs photoshoot and also hosted a tour to Moate history group.

The opening night of the Boyle Arts Festival took place at the house on Thursday 19th July with 360 people in attendance. The house was one of the key locations for events during the festival hosting 9 events including Luka Bloom, Brent Pope, Dave Geraghty from Bell X 1, Kevin Barry, Kieran Quinn & Seamie O'Dowd. A number of visual art exhibitions and workshops also took place at the house during the 10 day festival. A total of 3817 visitors came to King House during this year's festival.

Roscommon Arts Centre

- With the gallery now closed, the visual art programme has moved off site and arts centre staff
 have taken on roles within the arts office. The box office is operating on reduced hours, on
 Tuesdays and Thursdays only.
- All visual art projects are taking place offsite or are in production. Commissions in production are:
 Fiona McDonald "Gateways", Lucy McKenna "The Park Project IV", Anthony Keigher "Arts & Disability project" and Siobhan O'Connor "A Structural Force".
- The Roscommon Arts Centre commissioned exhibition "Florelegium" by Naomi Draper is currently touring and is exhibited at Limerick City Gallery until September.
- Writer in Residence Sue Rainsford is developing new writing on the upcoming exhibitions by Fiona McDonald & Lucy McKenna.
- Work is ongoing on the completion of the autumn/winter programme which has now gone to print
 and work is commencing on the pr & marketing of over 45 events. The first event of the season,
 Tommy Tiernan sold out in a record 4 hours earlier this month.
- Work has also commenced on the centre's 2019 Arts Council funding application, which is due early in September.
- Plans to re-locate the centre's box office facility to Aras an Chontae are also afoot with the build team due on site mid-August.

Heritage

- National Heritage Week: Over 50 events have now been registered for the county. The County Event Guide for National Heritage Week has been sent to print. .
- Farming Rathcroghan: European Innovation Project: Further project meetings took part and supporting documentation collated to progress the phase 2 project application.
- Castles in Communities Archaeological Field School Ballintubber: Roscommon County Council supported workshops and the Castle Open Day as part of the Ballintubber Heritage Weekend.
- Rathcroghan Cartoon Project: Pink Kong Studios have been appointed to create the animation for this project which is funded by the Heritage Council.
- County Roscommon Heritage Forum 3RD meeting of the year was held.

Local Enterprise Office:

- 101 enquiries were recorded.
- Two Mentor Clinics were held with 11 participants.
- 3 TOV Information Seminar took place with 6 clients attending.
- Ongoing one-to-one mentoring for the business community took place.
- A trainer/mentor has been appointed for the 2018 Lean for Business Programme and the recruitment process is nearing completion. A separate budget was secured from Enterprise Ireland for this initiative.
- A Taste of the Lakelands meeting took place regarding this year's Event in Lanesboro being supported by counties Roscommon and Longford.
- National Women's Enterprise Day (NWED) 18th October. LEO Roscommon is taking the Lead for the West Region. This year's Regional Ambassador has been chosen – Michelle Naughton-Daly, Deputy Managing Director, P & G Cards, Athleague. A client speaker has been sourced from each of the Mayo & Galway LEOs. The theme is 'from local to global'.
- P & G Cards celebrated 30 years in business on the 26th.
- A Leader Evaluation Meeting took place a member of the LEO is on the Leader Evaluation Committee.
- A FB Boost Your Business Event took place in Athlone with the LEO availing of this opportunity to promote the Trading Online Voucher Scheme.
- A meeting was held in Athlone ref: Athlone Shannon Feastival which will take place on 8th+9th September. This provides every possible opportunity to local businesses to engage with festival-goers and build business, while still being entertaining and engaging. - Trinno Project: HoE attended a meeting with NWRA. This is a food distribution initiative with Westbic and is ongoing. Partners will visit Roscommon in Sept/Oct.
- HoE attended a Local Strategy Group Meeting in Dublin for the National LEO Network.
- Erasmus: Leader Partnership Official Project Launch and Entrepreneurship Showcase took place in the Council Chamber. HoE made a Presentation on the LEO supports.
- Enterprise Ireland Graduate, Eilis Mullooly, commenced work in the LEO on the 16th July.
- The US representative in Rhode Island visited Ireland and was met by HoE and Minister Denis Naughten in Athlone. They also met with 3 Roscommon companies.

Vacant Sites:

• Sites are being advertised and two sold recently, with one current sale in progress.

Innovation Centre - Monksland:

- Steering Group meeting held on 31st July.
- RCC informed OIM of intention to progress with application under Rural Regeneration Programme for Innovation Centre.
- Application currently being developed.

STEM:

- Attended workshop on Ireland Funds with co-ordinator who is now going to follow up with Midland STEM project to see about learning from their experiences.
- Full time person to co-ordinate project is in place. In the meantime, ongoing work continues
 and preparatory work to extend what is involved will be put in place, as well as looking at
 other funding.
- STEM showcased to Minister Mary Mitchell O Connor in RCC offices on July 6th.
- 1st update report from new coordinator will be presented at September's Economic SPC.

Mainstreaming Student Entrepreneurship Conference:

Worked with Roscommon LEADER Partnership to host the Conference on 6th July in Council Chamber. This was the National launch of MASTER in Ireland the event was held to:

- 1. Demonstrate the importance of mainstreaming entrepreneurship education within VET for the benefit of individual students and wider regional development.
- 2. Publically recognise the achievements of the alliance.
- 3. Encourage the formation of other alliances in other Regions.
- 4. Showcase the methods available to educators to integrate entrepreneurship into main stream curriculum.
