Local Enterprise Office:

- 120 enquiries were recorded.
- Two Mentor Clinics were held with 15 participants.
- Ongoing one-to-one mentoring took place for the business community.
- 8 people took part in a TOV Information Seminar.
- An Innovation Voucher Clinic was held on the 11th with 9 enquiries.
- The following training was supported: SAGE Computerised accounts training finalised with 8 businesses, including follow-up on site visits; a Start Your Own Business Course was completed with 17 registered; a GDPR Information Seminar took place with 34 registered; Social Media for the Tourism Sector took place in the Enterprise Centre, Boyle and Social Media for Beginners took place in the Spool Factory, Boyle 14 participants on both; E-Commerce Website training took place with 10 participants.
- 'Lead to Succeed Fuelling Ambition Roadshow for Female Entrepreneurs' took place in the Hodson Bay Hotel on 1st led by Network Ireland Roscommon Branch & Enterprise Ireland and assisted by LEO Roscommon.
- Craft & Food businesses were supported at Lamb Festival w/e 4th.
- Fibre Arts Festival Event which was launched on the 4th was supported.
- LEO Roscommon supported Network Ireland Roscommon Branch with Judging of 'Women of the Year Awards' and the Awards Event in Castlecoote House on the 18th.
- Richard Siberry, Black Donkey Brewing Ltd., was interviewed at national level on the 19th. The National Final took place in the Mansion House on 24th May including a 20 year Celebration. Midland Precision Tool & Die was also invited as the 2001 National winners.
- Assistance was given to the 2 students from Curlew Mountain Forge, who represented Co.
 Roscommon in the Senior Category at the National Final of the Student Enterprise Programme
 on 2nd May in Croke Park. This team was one of just 8 teams invited to a publicity photo shoot
 in Croke Park on the 15th. At the request of Ireland AM the boys stayed overnight on the 2nd
 and appeared on TV on the morning of the 3rd.
- Head of Enterprise, Louise Ward, assisted in hosting the President of Cook County on her visit to Ireland on the 23rd.
- National Women's Enterprise Day (NWED): This yearly National Event is now run on a Regional basis and the date has been set: <u>Thursday, 18th October.</u> LEO Roscommon is taking the Lead for the West Region this year.

Planning Section Management Report - May 2018

Forward Planning

Vacant Site Levy work arising from the Urban Regeneration and Housing Act 2015

Work concluded on the analysis of submissions received from landowners in response to the issuing of 'Notices of Proposed Entry on the Vacant Sites Register' in March 2018. Arising from this the final identification of sites to be included on the Vacant Site Register has taken place, with detailed reports being prepared in justification of the identified lands. The preparation of formal notifications of inclusion on the register was on-going as part of work and that correspondence will issue over the coming weeks.

Monksland / Bellanamullia (Athlone West) Strategic Transport Assessment

The Strategic Transport Assessment which had been commissioned for the Athlone West area (i.e. the extent of area included within the Monksland / Bellanamullia LAP and its environs) was completed by consultants in April. A presentation summarising the findings and setting out the key recommendations was prepared for discussion at the Athlone Municipal District Meeting (which due to re-scheduling took place on June 1st).

Development Management (including enforcement activity)

The table below summarises Development Management activity in the Planning Section in May. A total of 49 valid applications were received by the Planning Authority, which was a marginal increase from the April figure of 45. A total of 29 pre-planning meetings were facilitated. 37 decisions were issued on planning applications, with 3 of those being refusals.

Unfinished Housing Developments

The Unfinished Housing Development team continued their work in May 2018, including undertaking site inspections and continued engagement with stakeholders.

Developers have been active in progressing agreed site resolution works in 7 developments, of which two are in Ballaghadereen, a further two in Rooskey and also one in Loughglynn.

Tenders were received from a number of contractors in relation to the undertaking of Site Resolution Works at developments in Boyle and Tarmonbarry, and were the subject of assessment by the UHD team and the consulting engineers engaged in respect of each of the relevant developments under RCC's Framework.

The taking in charge process progressed in respect of three housing developments (one in each of Boyle, Ballaghadereen and Cortober) with resolutions being passed to take the developments in charge at the Boyle Municipal District meeting on May 18th. The taking in charge process will not however formally conclude until the adoption of the minutes of that meeting at the next scheduled Boyle Municipal District meeting.

The visit will consist of a formal presentation by representatives of the local community highlighting their achievements and the reasons why they deserve a Pride of Place award. The format of the rest of the visit is up to each individual community but usually includes a short tour of the project/display.

Arts Programme

International Fibre Art Festival

The International Fibre Art Festival took place over four days at the beginning of May. 4th May at 7.00pm Civic Offices. This was the European launch of the 'Fate, Destiny and Self-Determination' installation – It has already toured Canada, China, Uruguay and USA. The 'Fate, Destiny and Self-Determination' installation consists of seven hundred pieces of woven art from four hundred participants from thirty-five countries around the world and is growing by the day. So, whenever it is being exhibited in a particular country, all the artists from or near that country who have a piece in it, attend.

Twenty weavers from Sweden, Denmark, Canada, the UK, and the US and all over Ireland booked in to a master-class in fine art weaving. Fifty people booked in to attend a symposium, which looked at issues of collaboration and communication. Because most fine art weavers work in isolation, they are beginning to look at ways of tacking this, by holding festivals such as this one. All of the people attending the festival were in the county for at least a week or ten days and added to the local economy.

Roscommon County Youth Orchestra (RCYO)

The summer concert of the Roscommon County Youth Orchestra took place in Hudson Bay on Saturday 26th may. Among the pieces performed were Celtic Gypsy, Lux Aeterna, Happy, Mozart Concerto and Rainy Day.

Roscommon Arts Centre

May was an exceptionally busy period at Roscommon Arts Centre with 36 events. The increased number of events was due to a number of short workshop programmes for both children and for older people in literature and theatre as part of our Bealtaine Programme.

Such was the demand for **Michael Harding's Memoir Writing** workshops, that an extra afternoon session had to be added to the schedule, with 24 participants in total taking part. A further 8

participants took part in **Julie Sharkey's Acting workshops**, while **Cathy Jordan's Songbirds choral workshops** resumed with between 20 & 25 people a week attending and **Catherine Donnelly's dance workshops** came to a conclusion with an onstage session.

Two Artist Development workshops, aimed at locally based artists in association with Visual Arts Ireland took place. Attended by 10 participants, the events focussed on Writing About your Work (delivered by Joanna Laws) and Documenting Your Work (Delivered by Tim Durham). Two Open calls for visual art commissions were announced: The Arts & Disability Commission & The Park Project Residency.

Theatre Artist Anna Newell embarked on a period of R&D at the centre with **Touched Theatre Company** for a new children's show entitled **"My Smile has Fallen Down"** that focuses on mental health issues, which the centre hopes to develop over the next three years with the artist. While we embarked on another series of **weekly early year's music workshops** with early year's music specialist Roisin Egan entitled **"Beat Buddy Babies"**

Theatre performances were courtesy of **Seamus O Rourke, Theatre Niche, Branar Theatre Company** and **Touched Theatre**. The music programme included **Seamie O'Dowd, John Joe Kelly & Kieran Quinn** in concert, while the PhotoIreland festival exhibition "In, Around & After Effects" continued in the gallery.

The centre also hosted the **launch of the new Tourism Strategy** and facilitated a **talk by Psychologist David Coleman** as organised by colleagues in Community & Enterprise.

Heritage

Rathcroghan Resource Community European Innovation Partnerships Project:

- The 'Sustainable Farming in the Rathcroghan Archaeological Landscape' project proposal has been selected for submission to the second round of the EIP open call process.
- Helena Fitzgerald Architects have been appointed by Rathcroghan Resource Community to prepare a detailed project plan for submission to the second round of the EIP Open Call process in August 2018.

2018 European Year of Cultural Heritage:

- Three heritage office projects have so far been granted permission to use the EYCH Label –
 Notice Nature Biodiversity Marquee @ Roscommon Lamb Festival Sunday 6th May, The Táin
 March @ Rathcroghan Mound Friday 18th May, Roscommon Graveyards Map Viewer date to
 be confirmed.
- Other events around the county have also been granted permission to use the EYCH Label.

The Táin March

 Primary school workshops with Heritage in Schools Scheme Expert Chris Thompson have been arranged with eight schools. School children will participate in the start of the Táin March @ Rathcroghan Mound on Friday 18th May.
