PLANNING DEPARTMENT

Forward Planning

The pre-draft public consultation period for the *Roscommon County Development Plan 2021-2027* ran until the 31st July 2020. Following the conclusion of this, forward planning activity in August focused on collating the information from the submissions, online survey, social media activity and public consultation workshops as part of the preparation of the Chief Executive's Report at pre-draft stage.

Development Management and Planning Enforcement Activity

The table below summarises Development Management activity in the Planning Section in August. A total of 38 valid applications were received, which was a significant drop from the number submitted in July. This is likely to be in part due to the traditional summer holiday period, as well as the knock on effect of the Covid 19 situation. Decisions issued on 33 planning applications, of which 27 were grants of permission.

Unfinished Housing Developments (UHD)

With regard to the Unfinished Housing Developments, developers were onsite in three developments in Frenchpark, Tarmonbarry and Lisacul, while contractors engaged by bodholders were active on a site in Monksland. Four developments were referred to Roads for Taking in Charge.

ECONOMIC AND DEVELOPMENT PROMOTION

Local Enterprise Office:

Trading On Line Vouchers (TOVs):

A total of 132 applications for TOVs were approved year to date. (A total of 123 TOVs have been approved with 90% funding since the funding was changed from 50% to 90%). A business which obtained a Voucher previously is eligible to apply for a second Voucher, if considered appropriate. The max grant remains at €2,500. A number of remote Information Seminars were held to facilitate clients wishing to apply as this is compulsory prior to making an application, with the next one is scheduled for the 8th Sept. Demand for this scheme locally and nationally is unprecedented.

- Business Continuity Vouchers: The total number of applications received is 233, with 186 being eligible for funding. Payment of vouchers is ongoing. Each voucher is worth up to €2,500 in third party consultancy costs and can be used by companies and sole traders to develop short-term and long-term strategies to respond to the Covid-19 pandemic.
- **Training:** Investigatory and preparatory work was done for autumn remote training which will go live on the LEO website in early September.
- **Remote Mentoring:** Is being provided on an ongoing basis for the business community on Finance, Business Advice, Planning, Social Media, Micro Finance, etc. Bookings are taking via the LEO website online booking system.
- **Enquiries:** Enquiries are ongoing and appropriate support is being provided.
- Student Enterprise Programme: It has been agreed that this Programme will go ahead for the school year 2020/2021, in remote format via videos and slides. Details of how it will be rolled out has been issued to all 9 second level schools in the county.
- National Women's Enterprise Day: This Event will take place remotely as a Nationally Event on the 14th October.
- National Enterprise Awards: At national level, it has been agreed that a physical Event for the 2020 winners is preferably but if that's not possible due to Covid-19, it will be postponed to 2021.
- **Promotion:** All LEO supports were promoted on the LEO website and on various social media platforms.
- Sites at Ballyboughan: 3 Enquiries ongoing.
- **Just Transition:** 3 applications submitted.

Community Enhancement Programme (CEP) – 2020

- The 2020 Community Enhancement Programme (CEP) was launched on the 22nd June by Minister Ring TD, Minister for Rural and Community Development.
- The CEP is funded by the Department of Rural and Community Development and will provide €2 million of grant funding towards enhancing the facilities available to

communities. The Programme has a focus on supporting groups in disadvantaged areas.

- Roscommon has been awarded €55,977 for 2020
- At a meeting of the LCDC on the 24th of June, the scheme was agreed as follows:
 - CEP 2020 advertised in both local papers with a closing date of 6th of August, 2020
 - o The scheme will be fully online this year via my online services.
 - There were two strands agreed:
 - Strand A: Grants for projects to the value of €1,000 will be funded.
 - Strand B: Grants for projects with a value exceeding €1,000 (subject to a maximum grant of €8,000) will be funded.

<u>Community Enhancement Programme (CEP) – 2020 fund for Community Centre and Community Buildings</u>

- Under the July stimulus package the government announced additional funding under CEP aimed towards funds for community centres and community buildings.
- The department allocation for this scheme aimed at community centres and community buildings is €113,318 for Roscommon.
- Due to the short timeframes surrounding same the application was published as per the department guidelines and per application form. This offered the following options to the applicant:
 - Small scale capital grant of €1,000
 - o Capital grant in excess of €1,000
- It was also agreed that this scheme would be online application made available from the 24th of August, 2020 with a closing date set for the 11th of September, 2020.

Pride of Place 2020

- Judging for the All-Island Pride of Place 2020 Competition took place on 26th and 27th August 2020 via Judges Zoom Call.
- Each call facilitated a Question & Answer session and provided each community group with an opportunity to elaborate on their submission and also facilitated judges to seek clarification.

Tidy Towns and Amenity Grants Scheme 2020

 Grant payments are being processed as works are completed and relevant documentation is submitted.

HERITAGE,

National Biodiversity Action Plan Funding (NBAP):

Projects ongoing under this funding stream include:

Pollinator Infomercials on Midwest Radio & Shannonside FM: these continued in August.

Ballintubber Biodiversity Photography Competition: Heritage Office sponsored professional photographer to judge the competition and also sponsored prizes and presented them.

Wildflower Verge in Elphin: Certified Irish wildflower seed mix was bought for Elphin Tidy Towns to sow on an agreed strip of road verge in the town as part of an ongoing road enhancement programme.

July Stimulus NBAP Additional Funding Application: An application was submitted for additional funding for control of Japanese Knotweed around the county.

Creative Ireland Funding:

'The Guided Tour' series: Creative Ireland funding was secured for two video guided tours with Dr. Kieran O'Conor— one of Roscommon Castle & one of Roscommon Abbey. Both videos are available on youtube along with a shorter version of each. https://www.youtube.com/channel/UC-vEj-GtOtAcmL3z5UnoJbQ These were promoted as part of National Heritage Week.

Heritage Council Funding:

Two projects ongoing under this funding are:

Field Monument Advisor for farming Rathcroghan EIP: project progressing. A newsletter & video were prepared for National Heritage Week.

Conservation Specifications for Masonry Ruins: Conservation architect was appointed to prepare a report for Rahara Medieval Church & the Owen O'Conor Mauseoleum in Ballintubber. Funding has yet to be sourced for reports for Elphin Cathedral & Cloonshanville Abbey

Department of Culture, Heritage & the Gaeltacht Funding:

July Stimulus HSF/BHIS Additional Funding Application: An application was submitted for additional funding 2 ongoing conservation projects in the county.

Rathcroghan - Royal Sites of Ireland World Heritage Tentative List Application: Work is progressing on completing the first draft of the application which must be submitted to DCHG at the end of September.

Heritage Officer Programme Review: The Heritage Council have commissioned consultants to carry out a review of the Heritage Officer Programme nationwide. Heritage Office participated in focus group sessions as part of the development of the review.

Tourism Development and Promotion:

COVID 19 – most Accommodation, Activities and Attractions in Roscommon opened. Feedback for August has been positive - a lot of northern Irish tourists and tourists from counties in Ireland would wouldn't normally visit Roscommon or IHH. Roscommon County continues to receive positive recognition for their adherence to COVID restrictions and social distancing measures.

COVID 19 INITIATIVES:

Roscommon Community Response Forum:

As part of the Governments response to the COVID-19 crisis, Roscommon County Council in partnership with principal response agencies and community and voluntary groups have come together to form the Community Response Forum to lead the co-ordination of the COVID-19 community supports and resilience. The Forum beings together a number of organisations to identify vulnerable groups and individual in Roscommon and to ensure delivery of targeted social care supports and assistance to vulnerable groups and individuals.

The Forum met three times in June and August and will continue to meet regularly to discuss and resolve matters utilising the expertise contained within this multi partnership team.

Community Support Response Helpline:

Roscommon County Council in partnership with An Garda Siochana and Roscommon Leader Company have set up a 24 hour Freephone community support response help line to assist in the delivery of targeted social care supports and assistance to vulnerable groups and individuals. In June, the response line hours were altered to 9am-5pm over 7 days. During the month of August, 3 for support were successfully delivered through the Partners.

- John McGahern Exhibition installation continues at The Barracks Cootehall to be opened March 2021 as part of Galway 2020 Outreach Programme.

Roscommon Arts Centre

Exhibition Programme: and Mark Garry's installation "An Lucht Siuil" opened in the gallery space on August 6th. In line with Government restrictions, no opening took place to co-include with Mark's show, but rather a new online video piece was released to co-incide with the show.

Performance Programme: The performance programme re-commenced at the end of July with "The Reel Thing" a new music series which focuses strongly on Roscommon musicians. Short, one-hour performances, with audiences of up to 50 people are now being delivered — the first of which featured Cathy Jordan, Sean Regan and Kim Fleming and sold out.

Studio 2020: As part of Roscommon Arts Centre's ongoing supports to artists, an open invitation was issued to artists working in all disciplines to avail of free studio spaces at the centre for a duration of six weeks in August/September. Three Roscommon based artists are now in residence: David Pierce (visual artist); Louise Shine (visual artist) and Mintesinot Getachew (contemporary dancer).

Creative Ireland Music & Dance Residencies: With the support of Creative Ireland, Roscommon Arts Centre devised two three month residencies aimed at artists working in dance and music, the recipients of which will be announced in September. The residencies will run from October – December 2020 and include access to studio space at the arts centre.

Appointment of new Curator in Residence for 2020/2021: With the support of The Arts Council of Ireland, Roscommon Arts Centre appointed Naomi Draper as Curator in Residence for 2020/2021. Following an Open Call, 5 applicants were interviewed for the post. Naomi will take up this role in September.

Lookseedoo: Roscommon Arts Centre's free online summer programme for young people continued in August with weekly engagements.
