The ambition of the guide is to encourage sustainable consumption and reduction of waste being sent to landfill or for incineration. This guide will provide advice to households on waste disposal and recycling options available in County Roscommon, with an emphasis on waste reduction, reuse, recycling and the circular economy.

*An Authorised Waste Collector is a person or company authorised by the National Waste Collection Permit Office (NWCPO) to collect waste subject to certain conditions. It is a criminal offence for any person or business to give their waste to an unauthorised waste collector. Penalties on conviction can be up to €5,000 and/or 12 months imprisonment.

WASTE PRESENTATION BYE-LAWS

WHY DO WE NEED THESE BYE-LAWS?

- To help you manage your waste in an environmentally acceptable manner:
- To ensure that your waste is only given to an authorised door-todoor waste collector or brought to an authorised waste facility;
- To help ensure your waste is correctly segregated;
- To reduce illegal dumping and backyard burning.

HOW DO I COMPLY WITH BYE-LAWS?

In order to manage your waste correctly you need to be able to prove that:

 You have a contract in place with an authorised waste collector (bin sharing is permitted for which proof of agreement is required);

OR

You can demonstrate regular use of an authorised waste facility.

IS THERE ANYTHING ELSE I NEED TO DO?

- You must segregate recyclable waste from your residual waste and present these separately. If you are living in an urban area, small town or village with a population of over 500 you must also segregate your food waste.
- ▶ Kerbside waste presented for collection shall not be presented for collection earlier than 6:00pm on the day immediately preceding the designated waste collection day.
- ▶ All Containers used for the presentation of the kerbside waste and any uncollected waste shall be removed from any roadway, footway, footpath or any other public place no later than 9:00am on the day following the designated waste collection day.

WASTE PRESENTATION BYE-LAWS

WHAT DO I DO IF I LIVE IN A MANAGED APARTMENT COMPLEX?

The bye-laws will still apply; the management company is to ensure adequate containers are provided for residual and recyclable waste in designated waste storage points. They are also obliged to provide you with the written information regarding the arrangements in place. Segregation within the apartments will be the responsibility of the occupant. In order for the segregated system to work all apartments must play their part.

WHAT HAPPENS IF I DON'T COMPLY?

If you fail to comply with any of the requirements of the bye-laws it may result in a Fixed Penalty Notice (Maximum €75) being issued by this Local Authority or a member of An Garda Síochána. It may also lead to a fine on conviction of up to €2,500.



HOUSEHOLD RECYCLING BIN (BLUE BIN)

A kerbside waste collection service is provided for householders in County Roscommon by private waste collectors. A waste collector must have a valid waste collection permit to collect waste in Roscommon. Waste collectors provide a segregated waste collection system - they collect general waste, mixed dry recycling and food waste.

What can be placed in the Blue Bin?

- Paper
- Cardboard
- Magazines/Brochures
- Soft Plastics (Bags/Wrappers etc)
- Rigid Plastics (Plastic Bottles/Tubs etc)
- ⊘ Tetra Pak (Cartons)
- Food Tins (Steel)
- O Drinks Cans (Aluminium)
- **⊗** NO GLASS

All Recycling should be Clean, Dry & Loose.



FOOD WASTE RECYCLING BIN (BROWN BIN)

All households in Ireland produce food waste. Some of it is unavoidable such as vegetable peelings and bones. Some households also produce unavoidable food waste by overbuying food or not using up food before it goes out of date. If you have been provided with a brown food waste bin that is collected at the kerbside, then you can place the majority of your uncooked and cooked food waste in that bin,

What can be placed in the Brown Bin?

- Uncooked food waste
- Cooked food waste
- Leftover food and plate scrapings
- ✓ Meat, poultry, fish and bones
- O Dairy products
- Egg products
- Coffee grinds and tea bags
- Fruit and vegetables

We fully support home composting and encourage householders to use a home compost bin to manage their garden waste and uncooked vegetable food waste.

Always remember to remove packaging before placing food waste into the brown bin.

Use a compostable liner or some paper to keep your kitchen bin clean. Do not use a plastic bag.



RESIDUAL WASTE BIN (BLACK BIN)

Use your residual waste bin for all household waste that cannot be recycled or composted.

What can be placed in the Black Bin?

- Ocontaminated / dirty packaging or containers
- Food contaminated packaging
- Ashes (cold)
- ✓ Toothpaste tubes
- Sanitary Waste
- Nappies
- Ceramics

BRING BANKS

There are currently 38 bring bank sites located across County Roscommon, which facilitate the recycling of glass jars/bottles and aluminium drinks cans. Textile banks are located at a number of these sites.

Follow this advice when using the bring bank sites:

DO

- ② Ensure all glass jars/bottles and aluminium drinks cans you place in the bring banks are clean.
- Make sure any household textiles are clean before putting them in the textile bank for recycling.
- If the bring banks are full, please use an alternative site or come back another day.
- OBring your bags and boxes home to reuse them.

DON'T

🚫 Place any ceramics, tiles, mirrors or pyrex in the banks.

CIVIC AMENITY SITE CHARGES

County Roscommon Civic Amenity Sites operate a white, green and yellow ticket system for disposing of recyclable and some hazardous household waste items. All tickets and blue refuse bags for general residual household waste are available for purchase at local outlets throughout County Roscommon.

CIVIC AMENITY SITE CHARGES

Pre-sort your items before visiting the Civic Amenity Sites, all packaging for recycling should be clean, dry and loose. A recycling ticket needs to be purchased to dispose of any of the following items.

LOCATIONS AND OPENING HOURS OF CIVIC AMENITY SITES

There are **four Civic Amenity Sites in County Roscommon** located at **Ballaghaderreen**, **Boyle**, **Castlerea and Roscommon**. These Civic Amenity Sites are for the recycling of household waste only.

Only clean and dry household recycling will be accepted.

Give your waste electricals, batteries and bulbs a new life!

Recycle for FREE!

WASTE ELECTRICAL AND ELECTRONIC EQUIPMENT (WEEE) IS ANYTHING THAT HAS A PLUG OR BATTERY AND IS AT THE END OF ITS USEFUL LIFE

WEEE must not be placed in household bins due to the hazardous nature of such items.

- When you purchase a new electrical, electronic or battery operated appliance or piece of equipment the retailer or supplier is required to take back your old appliance or equipment similar to the appliance or equipment you purchased, free of charge.
- You can also recycle batteries, fluorescent tubes and anything electric or electronic (with a plug or battery) at your local Civic Amenity Site check out the information on pages 12-16 about Civic Amenity Sites in Roscommon.
- Every battery you recycle in the blue WEEE Ireland battery boxes helps raise vital funds for LauraLynn, Ireland's Children's Hospice.
- Small Things Matter, small items with a plug or battery can be recycled for free too!

Some Simple Advice

- Before disposing of WEEE consider repairing it
- Retailers of batteries take back similar type batteries, no purchase necessary
- Some large electrical retailers take back WEEE without any purchase

HOME COMPOSTING AND GREEN WASTE

Home compost bins are suitable for anyone looking to start composting items like fruit, veg, eggshells, teabags and grass cuttings. It is a great way to reduce this type of waste from your bins. You may also be interested in other composting techniques such as compost piles, wormeries and other systems. Compost is rich in nutrients and when used in your garden and on your plants, feeds the ecosystem of the soil and slowly releases nutrients that plants can absorb.

Green waste should be separated out from other waste and you should choose one or more of the following options to deal with it:

- Use a compost bin or compost heap and compost in your own garden.
- Invest in a mulching mower.
- Hire a shredder and shred hedge clipping and branches and make your own bark mulch.

Hire a skip from an authorised waste collector.

ELV's - END OF LIFE VEHICLES

THINKING OF DISPOSING OF AN OLD VEHICLE, TWO THINGS TO CONSIDER

- Have I engaged an authorised end-of-life vehicle operator who can ensure my vehicle is dealt with and disposed of in line with legislation, regulations and in a way that protects the environment?
- Will the operator provide me with a certificate of destruction (COD) for my records so that I can demonstrate that I have met my obligations under the Waste Management Act 1996 as amended as the registered owner of the vehicle? CODs are also required for claiming any motor tax back that you may be eligible for.



BACKYARD BURNING

BACKYARD BURNING REFERS TO THE UNCONTROLLED BURNING OF WASTE

It also refers to the burning of any waste in:

- Open fires
- Ranges
- Other solid fuel appliances or in the open

IT IS ILLEGAL TO BURN HOUSEHOLD OR GARDEN WASTE IN ANY WAY OR AT ANY TIME.

Burning waste in your home or garden can damage your health, as well as that of your children and your neighbours. Such illegal practices lead to the release of toxic dioxins which are a real hazard for people's health and the environment.

If your neighbour or someone else you see is illegally burning waste, then in the interest of your own health and the environment, please report it. Please find information on how to report illegal burning of waste on page 25.

UNAUTHORISED WASTE COLLECTORS

It is a criminal offence for any person or business to give their waste to an unauthorised waste collector. Penalties on conviction can be up to €5,000

and/or 12 months imprisonment.

You must always ensure that any company or person you engage to collect your waste possesses a valid Waste Collection Permit. Any reputable waste collector is obliged to display the waste collection permit number on all vehicles, flyers and receipts. You can check if the waste collector is authorised on the National Waste Collection Permit Office website - www.nwcpo.ie

Unauthorised waste collectors may not dispose of your waste in an environmentally safe or responsible manner, often the waste is fly-tipped by the roadside or in scenic areas, incurring significant clean up costs and potential prosecution of the original waste owner.

FARM PLASTICS RECYCLING

Irish Farm Film Producers Group CLG (IFFPG) is Ireland's only government-licensed recycling compliance scheme, responsible for providing an efficient and cost-effective farm plastics recycling service to farmers nationwide. IFFPG collects both at the farmyard and at bring-centres.

Options available to dispose of farm plastics correctly:

- Farmyard Collections Organise a collection directly from your farmyard through IFFPG.
- Bring Centres One or two day events, arranged by the IFFPG, to which farmers can bring their farm plastics for recycling each year.
- Authorised Waste Collectors waste collectors collecting farm plastic must be authorised in their collection permit to collect farm plastics and deliver it to an authorised waste facility.



- Please secure load of plastic before hauling plastic into local bring centres
- · Chemical drums need to be triple rinsed
- Oil drums are not accepted
- Farm plastics that can be collected for recycling include silage wrap/pit covers, fertiliser/feed bags (liners removed) chemical containers, netting and twine,


